

Starters, Completers and Early Leavers Per Month




- o Most months, New Hall started between 30 and 70 beneficiaries on the PS Plus 2 project.
- o Up until the last 4 months of the project, no more than 45 beneficiaries were completing the PS Plus 2 project per month.





Cumulative Starters, Completers and Early Leavers




- o 834 beneficiaries were started on PS Plus 2 in New Hall.
- o 730 beneficiaries finished in New Hall 569 completed the project and 161 left the project early.


- o Of the 161 beneficiaries who left the project early, 35% (56) transferred to a non-PS Plus establishment.
- o 7% (11) of the beneficiaries who left early did so because they were disengaged.
- $\circ\quad$ 5 of the early leavers decided not to continue on the PS Plus project.

- o Most months, less than 25 prisoners were seen and deemed unsuitable for the project.
- o In total, nearly 250 prisoners were not started on the PS Plus 2 project in New Hall.
- o 64 of the prisoners not started in New Hall did not require PS Plus Services and 64 prisoners transferred before being started on the project (13 transferred before assessment was entered and 51 to a non-PS Plus establishment).








Nationality of Prisoners Not Started


- The majority of the prisoners not started on the PS Plus project were White-British (57%) and from United Kingdom (71%).
- o The ethnic origin for 32% and the nationality of 17% of the prisoners not started was unknown.
- Ethnic minorities account for 11% (27 prisoners) of the prisoners not started.





Beneficiaries Started On PS Plus

Ethnic Breakdown of Beneficiaries in New Hall



- o 90% (748) of the beneficiaries started and 91% (661) of the beneficiaries who finished in New Hall were White-British.
- o 10% (85) of the beneficiaries started and 9% (69) of the beneficiaries who finished in New Hall were from ethnic minorities.
- o The ethnic origin of one of the beneficiaries who started in New Hall is unknown.



- o 95% (792) of the beneficiaries started in New Hall stated that their nationality is United Kingdom, British or English.
- o 95% (693) of the beneficiaries who finished in New Hall stated that their nationality is United Kingdom, British or English.
- The nationality of 27 of the beneficiaries started in New Hall and 25 of the beneficiaries that finished in New Hall was unknown.





Age and Dossier Number of Beneficiaries on Starting PS Plus 2




- The average (mean) age of the beneficiaries started in New Hall is 28 years and 9 months. The average (mode) age group is 21 – 30 years old.
- o There are no beneficiaries in New Hall above the age of 61.








Disabled Beneficiaries



Beneficiaries Starting in New Hall




Beneficiaries Finishing in New Hall

- o 2% (16) of the beneficiaries who started in New Hall were classified as being disabled.
- \circ 2% (15) of the beneficiaries who finished in New Hall were classified as being disabled.



Needs of the Beneficiaries Started in New Hall




- Over 90% of the beneficiaries who started in New Hall needed help with education, while nearly 80% needed help with employment.
- Nearly 60% of the beneficiaries who started in New Hall needed help with drug issues.
- Over 30% of the beneficiaries who started in New Hall needed help with housing issues.





Beneficiary Background




- o Nearly 700 of the beneficiaries who started in New Hall were ex-offenders.
- Over 400 of the beneficiaries who started in New Hall had a drug or alcohol problem and over 500 are on the labour market.
- o There were 23 lone parents in New Hall







Transfers from other PS Plus Establishments




- o 132 beneficiaries have transferred into New Hall 91% transferred into New Hall from Styal or Askham Grange.
- o 34 beneficiaries have transferred from New Hall 82% transferred from New Hall to Drake Hall or Askham Grange.






Beneficiaries that have No Fixed Abode



- o 5% (38) of the beneficiaries started in New Hall were classed as having no fixed abode on starting the project.
- o 38 beneficiaries were classed as having no fixed abode on finishing the project. Of these, 18 had an accommodation outcome secured.







- o For approximately 550 beneficiaries, the level of risk of harm is unknown.
- o Where risk is known, the majority of the beneficiaries are low risk prisoners.



- o 1437 soft outcomes were gained by New Hall beneficiaries.
- o 306 beneficiaries received IAG assistance.
- o 138 beneficiaries were on the Fresh Start Programme.
- o Beneficiaries in New Hall attended 385 interviews Further Education, Fresh Start, Job and Progress to Work interviews.
- o 121 beneficiaries attended Job Club.










- o 98% (217) of the exams taken were passed.

- o No exams were failed.





- o 29 NVQ levels 1 and 2 have been gained by beneficiaries in New Hall.
- o 61 adult Literacy and numeracy courses have been passed by beneficiaries in New Hall.






- o 179,954 hours were collected from PS Plus beneficiaries.
- o 139,468 (78%) of the hours collected were for practical activities.







Hard Outcomes



- 105 hard education, training and employment (ETE) outcomes have been recorded at New Hall with evidence for 30 of these outcomes (29% evidence for outcome rate).
- 190 hard accommodation outcomes have been recorded with evidence for 95 outcomes (50% evidence for outcome rate).
