

# Starters, Completers and Early Leavers Per Month




- o Most months, Styal started between 30 and 80 beneficiaries on the PS Plus 2 project.
- Up until the last 7 months of the project (project closure), no more than 61 beneficiaries were completing the PS Plus 2 project per month.





### Cumulative Starters, Completers and Early Leavers




- o Over 1500 beneficiaries were started on PS Plus 2 in Styal.
- o Approximately 1230 beneficiaries finished in Styal 1034 completed the project and 200 left the project early.


- o Of the 200 beneficiaries who left the project early, 6% (154) transferred to a non-PS Plus establishment.
- o 12 beneficiaries opted out of PS Plus and 11 left early because they were ineligible.


- o Most months, over 60 prisoners were seen and deemed unsuitable for the project. There has been a general decline in the number of non-starters at Styal.
- In total, over 1600 prisoners were not started on the PS Plus 2 project in Styal.
- o 247 of the prisoners not started in Styal did not require PS Plus Services and 915 prisoners transferred before being started on the project (66 transferred before the assessment entered and 849 to a non-PS Plus establishment).

- Where known, the majority of the prisoners not started on the PS Plus project were White-British (36%) and from United Kingdom (47%).
- o The ethnic origin for 3 in 5 and the nationality of 45% of the prisoners not started was unknown.
- Ethnic minorities account for 4% (64 prisoners) of the prisoners not started.








#### Beneficiaries Started On PS Plus

#### Ethnic Breakdown of Beneficiaries in Styal



Started in Styal Finished in Styal

- o 92% (1390) of the beneficiaries who started and 92% (1135) of the beneficiaries who finished in Styal were White-British.
- o 8% (123) of the beneficiaries who started and 8% (97) of the beneficiaries who finished in Styal were from ethnic minorities.
- The ethnic origin of two beneficiaries who started and one beneficiary who finished in Styal is unknown.



- o 82% (1249) of the beneficiaries who started in Styal stated that their nationality is United Kingdom, British or English.
- o 84% (1035) of the beneficiaries who finished in Styal stated that their Nationality is United Kingdom, British or English.
- The nationality of 227 of the beneficiaries who started in Styal and 168 of the beneficiaries who finished in Styal is unknown.





# Age and Dossier Number of Beneficiaries on Starting PS Plus 2




- o The average (mean) age of the beneficiaries started in Styal is 31 years and 7 months. The average (mode) age group is 21 − 30 years old.
- o All 1515 of the beneficiaries are in the ESF Group 041009ES3 (female beneficiaries).



- o 7% (103) of the beneficiaries who started in Styal were classified as being disabled.
- o 7% (89) of the beneficiaries who finished in Styal were classified as being disabled.




#### Needs of the Beneficiaries Started in Styal



- o Over 90% of the beneficiaries who started in Styal needed help with employment and over 90% needed help with education.
- o Over 60% of the beneficiaries who started in Styal needed help with housing issues.
- Over 50% of the beneficiaries who started in Styal needed help with health issues.



#### **Beneficiary Background**




- Over 900 of the beneficiaries who started in Styal were ex-offenders.
- o Over 700 of the beneficiaries who started in Styal had a drug or alcohol problem and are on the labour market.
- o Over 200 of the beneficiaries who started in Styal were lone parents.





# Transfers from other PS Plus Establishments




- o 150 beneficiaries have transferred into Styal 65% transferred to Styal from Buckley Hall.
- o 267 beneficiaries have transferred from Styal 76% transferred from Styal to Drake Hall and New Hall.

#### Beneficiaries that have No Fixed Abode




o 14% (213) of the beneficiaries started in Styal were classed as having no fixed abode on starting the project.

Beneficiaries Starting in Styal

 154 beneficiaries were classed as having no fixed abode on finishing the project. Of these, 42 had an accommodation outcome secured.







- o For approximately 1200 beneficiaries, the level of risk of harm is unknown.
- o Where risk is known, the majority of the beneficiaries are low risk prisoners.



- o 1350 soft outcomes were gained by Styal beneficiaries.
- o 350 beneficiaries gained work experience while in custody.
- o 80 beneficiaries had their rent arrears addressed.
- Beneficiaries in Styal attended 191 interviews Further Education, Fresh start, Homeless, Job, New Deal, and Progress
  to Work interviews.





# Exam Results




- o 94% (125) of the exams taken were passed.
- o Only 4% of exams were failed.



# **Timesheet Hours**




- o 168,993 hours were collected from PS Plus beneficiaries.
- o 75,103 (44%) of the hours collected were for gaining guidance.








#### **Hard Outcomes**





- o 186 hard, training and employment (ETE) outcomes have been recorded at Styal with evidence for 101 of these outcomes (54% evidence for outcome rate).
- 255 hard accommodation outcomes have been recorded with evidence for 175 outcomes (69% evidence for outcome rate).
