

# Starters, Completers and Early Leavers Per Month




- o For the first 19 months, no more than 41 beneficiaries were started in Wymott. For the next 8 months, the number of starters remained constant at 66 for 2 months, then 55 until the last few months (project closure).
- Up until the last 7 months of the project (project closure), no more than 30 beneficiaries were completing the PS Plus 2
  project per month.





# Cumulative Starters, Completers and Early Leavers




- $\circ\ \ \,$  Over 850 beneficiaries were started on PS Plus 2 in Wymott.
- o Almost 1000 beneficiaries finished in Wymott 877 completed the project and 104 left the project early.



- o Of the 104 beneficiaries who left the project early, 35% (37) transferred to a non-PS Plus establishment.
- o 26 beneficiaries decided not to continue on the project and 2 beneficiaries absconded.


- o Most months, less then 25 prisoners were seen and deemed unsuitable for the project.
- o In total, 372 prisoners were not started on the PS Plus 2 project in Wymott.
- 132 of the prisoners not started in Wymott did not wish to be considered for the PS Plus project and 68 prisoners transferred before being started on the project (24 transferred before the assessment entered and 44 to a non-PS Plus establishment).

- The majority of the prisoners not started on the PS Plus project were White-British (63%) and from United Kingdom (79%).
- o The ethnic origin for 28% and the nationality of 18% of the prisoners not started was unknown.
- o Ethnic minorities account for 9% (34 prisoners) of the prisoners not started.








#### Beneficiaries Started On PS Plus

#### Ethnic Breakdown of Beneficiaries in Wymott



- o 90% (770) of the beneficiaries who started and 89% (878) of the beneficiaries who finished in Wymott were White-British.
- 10% (87) of the beneficiaries who started and 11% (103) of the beneficiaries who finished in Wymott were from ethnic minorities.



- o 87% (745) of the beneficiaries who started in Wymott stated that their nationality is United Kingdom or British.
- o 88% (866) of the beneficiaries who finished in Wymott stated that their nationality is United Kingdom or British.
- The nationalities of 94 of the beneficiaries who started and 91 of the beneficiaries who finished in Wymott are unknown.





# Age and Dossier Number of Beneficiaries on Starting PS Plus 2




- o The average (mean) age of the beneficiaries started in Wymott is 34 years and 10 months. The average (mode) age group is 21 − 30 years old.
- o 70% (601) of the beneficiaries are in the ESF Group 041007ES3 (male beneficiaries aged 28 and over).





- o 4% (36) of the beneficiaries who started in Wymott were classified as being disabled.
- o 4% (37) of the beneficiaries who finished in Wymott were classified as being disabled.



#### Needs of the Beneficiaries Started in Wymott




- Over 90% of the beneficiaries who started in Wymott needed help with employment and 90% needed help with education.
- Nearly 50% of the beneficiaries who started in Wymott needed help with housing issues.
- Nearly 40% of the beneficiaries who started in Wymott needed help with behaviour issues.





# **Beneficiary Background**




- 180 of the beneficiaries who started in Wymott were ex-offenders.
- $\circ\quad$  170 of the beneficiaries who started in Wymott are on the labour market.







#### Transfers from other PS Plus Establishments





- 432 beneficiaries have transferred into Wymott 84% transferred to Wymott from Preston, Kirkham, Risley, Haverigg or Forest Bank.
- 235 beneficiaries have transferred from Wymott 83% transferred from Wymott to Kirkham, Risley, Lancaster Castle, Haverigg or Sudbury.





#### Beneficiaries that have No Fixed Abode





Beneficiaries Finishing in Wymott

- o 10% (87) of the beneficiaries who started in Wymott were classed as having no fixed abode on starting the project.
- o 113 beneficiaries were classed as having no fixed abode on finishing the project. Of these, 31 had an accommodation outcome secured.





- o For over 200 beneficiaries, the level of risk of harm is unknown.
- o Where risk is known, the majority of the beneficiaries are low risk prisoners.





- o 560 soft outcomes were gained by Wymott beneficiaries.
- o 82 beneficiaries received IAG assistance.
- o 39 beneficiaries attended ECDL.
- Beneficiaries in Wymott attended 120 interviews Further Education, Fresh Start, Homeless, New Deal and Progress to Work interviews.
- o 32 beneficiaries received Advice on Disclosure.








- o 89% (363) of the exams taken were passed.



- o 281 NVQ levels 1 and 2 have been gained by beneficiaries in Wymott.
- o 50 adult literacy and numeracy courses have been passed by beneficiaries in Wymott.
- o 168 beneficiaries in Wymott completed an ECDL course.






## **Timesheet Hours**



- o 397,332 hours were collected from PS Plus beneficiaries.
- o 290,746 (73%) of the hours collected were for practical activities.



#### **Hard Outcomes**



- o 162 hard education, training and employment (ETE) outcomes have been recorded at Wymott with evidence for 47 of these outcomes (29% evidence for outcome rate).
- o 78 hard accommodation outcomes have been recorded with evidence for 34 outcomes (44% evidence for outcome rate).
